Equipment	All Butterfly equipment: tables, nets, barriers and white 3 star 40mm balls. Play is on hardwood floor.

Entry Deadline	Entries must be postmarked by Monday, July 21st, 2014 . Entries posted after the deadline will charged \$10 late fee.
Refunds	No refunds after entry deadline.
Ratings	For event eligibility, the 06/30 USATT web site published ratings will be used. Seeding will be based on most current ratings.
Policies	Players may not enter two events with same start times. For unrated players, initial rating will be estimated by the Tournament Committee. Events can be cancelled or combined at the discretion of the tournament committee. Events with insufficient entries may be cancelled and refunds issued. No prizes will be awarded for splits, dumps, default losses or no-shows. Play will be conducted under ITTF rules. USATT dress code will be enforced. All decisions of the referee are final.
Note	Players who receive \$600 or more must fill out Form W-9 (Request for Social Security or Employer ID number). Open Singles Semi and Final Schedules (Sunday, July 27, 2014): * Semifinals: 11:00 AM. * Final: 1:00 PM. All matches will be best of 5 games to 11 points, except the Open Singles final, which will be best of 7 games. All players MUST check-in at least 30 minutes prior to their first match play.

From I-90 eastbound. Take exit 11A and follow the signs to 156th Ave. S.E. The ramp will merge you onto So. 150th heading North and get in the left lane. Turn left at S.E. 28th St. into BC's main entrance. Proceed to the traffic circle, turn to the right, then head straight onto the road east of the parking garage (follow the road when it bends left).

From I-90 westbound to Exit 11. After exiting, follow the signs for 156th Ave. SE. At the stoplight, turn left onto Eastgate Way. Move into the right lane and turn right at 150th Ave. SE. Get in the left lane and proceed up the hill. At the stoplight (S.E.28th St.) turn left into BC's main entrance. Proceed to the traffic circle, turn to the right, then head straight onto the road east of the parking garage (follow the road when it bends left).
